ZBA LETTERS OF INTEREST

The Board determined that they can't move forward with the letters of interest for the Joint Zoning Board of Appeals Board at this time. First, the Village's law to create a joint ZBA needs to mirror the Town's law. The Town attorney said she is willing to work with the Village attorney and will reach out to him. It is tabled for now.

TUSCARORA PARK

The Town of Mount Morris is applying for a 20,000 grant for improvements to Tuscarora Park. Deputy Supervisor Don Huff submitted the proposed improvements to the Board, and they approved. David DiSalvo will submit the proposal to the County.

Deputy Supervisor Huff feels we need to install cameras at the Park. There has been some damage to playground equipment recently. He feels it may be worth looking into.

Deputy Supervisor Huff thanked Highway Supervisor Sam Cipriano for all the extra effort he and the crew have put into the park.

The upcoming Music in the Park event will take place August 18th. Councilmember Jeff Coniglio will be scheduling the bands and vendors.

Deputy Supervisor Huff will be checking with the Amish about planting the flowerbed.

HOT WATER TANK

Recently the hot water tank leaked. Deputy Supervisor Don Huff stated there is no point in repairing the tank, it needs to be replaced. After discussing whether the Town Hall needs to have hot water, it was decided to get prices on an on- demand hot water tank. Councilmember Guzzardi is going to get several prices.

Supervisor DiSalvo reported that Marchese Computer Products has put our server in place.

Ambulance

Supervisor DiSalvo reported they are getting back to pre-Covid numbers. Basic Life Support numbers are higher than Advanced Life Support numbers. Miles have almost doubled.

HIGHWAY

Highway Superintendent Sam Cipriano reported they are doing lots of shopwork this month. They are rebuilding the conveyor system. They have put \$5,000 into it and possibly \$3,000 more will be needed. A new body would have cost \$23,000.

Sam recommended we start advertising for 2 highway positions. We have one employee with an upcoming retirement with possibly another retiring. Also, one employee will be on medical leave for 6 weeks. We recently hired two seasonal employees for the cemetery.

The highway crew will be replacing a culvert at the intersection of Ridge and Creek on April 24th and 25th. Creek Rd. will be closed between Frost Rd. and Ridge Rd. on those days.

A water customer has an apartment which they no longer want to use as a dwelling. They would like to disconnect the water and sewer. This will reduce the EDU's being charged on this customer's account.

There was discussion about the gas service for the pump station at 6400 Sonyea Rd. The Town has already prepaid for this service in October of 2022 and it is not up and running yet. There was discussion on possibly switching to LP. Supervisor DiSalvo will reach out to our attorneys to see if switching to LP is an option.

CEMETERY

Councilmember Nate Guzzardi brought up for discussion putting a gate at the cemetery entrance afterhours. He asked how formal a gate is required. He will look into prices.

TRANSFER STATION

The driveway out front is in bad shape and will need repaving. Karl Schrier has picked up the cardboard and will pick up again.

CODE ENFORCEMENT

Code Enforcement Officer, Shawn Grasby spoke about putting a Solar Moratorium law in place. We have already extended our temporary moratorium twice.

Supervisor DiSalvo received a letter from a concerned citizen who has property on Wildcat Rd. They are inquiring if we have a noise ordinance in place. They are hearing guns and what sound like cannons going off. A radar gun would need to be used to test the noise. The attorneys say the best way is to work with the landowner. The Supervisor will write the resident back.

Code Enforcement Office Grasby and Councilmember Coniglio have applied for funds from the EDF program "Funds in the Sun". They applied for \$5,000 for restoration of headstones in the cemetery and \$5,000 for Music in the Park event.

JOINT SUMMER RECREATION PROGRAM

The attorneys are still working on the contract for the summer rec program.
